## Temperatures Continue to Climb



We know it can be crucial to keep your home cool this Summer. As part of our Energy Crisis Intervention Program (ECIP), we have two ways to help you stay cool if your household is eligible - providing window air conditioner units or repairing central air conditioning units. Both options require an appointment with a community services worker in order to be deemed eligible. The qualifications for each are below...

### Window Air Conditioner Eligibility Requirements

- The household did not receive an air conditioner from this program in the past fiscal year.
- The household meets the federal income guidelines (below 200% poverty level).
- Someone in the household has a medical condition that is worsened by the heat.
- The home does not have central air conditioning.
- If renting, you must have a signed letter of permission from their landlord.
- If you own the home, we must have proof of home ownership.

### Central Air Conditioner Repair Requirements

- Applicant must own the home.
- The household meets the federal income guidelines (below 200% poverty level).
- Someone in the household has a medical condition that is worsened by the heat.

If the applicant meets all of the listed criteria, the household is eligible to receive emergency cooling assistance. If you have any questions about these assistance programs or would like to schedule an appointment please call 712-274-1610.

**It's easy to prove eligibility with any of the following:**

-  A notice of approval for food assistance
-  Other official documentation

There are four ways that families can be automatically eligible for our Early Childhood Programs.

1. Household approved for SNAP Benefits
2. Any member of the household receives Social Security Supplemental income
3. Household approved for FIP/TANF Assistance
4. Household is lacking a permanent residence (i.e. homeless)

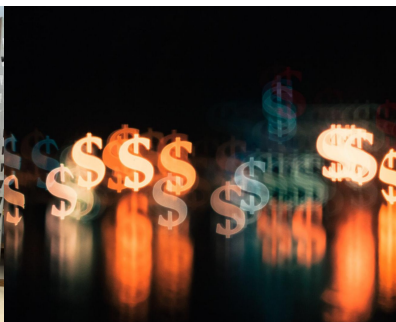
## New Development Director
